DURING FY21, THE LOWCOUNTRY LAND TRUST (LLT) COMPLETED 5 NEW CONSERVATION EASEMENT PROJECTS, FOR A TOTAL OF 3,006.96 NEWLY PROTECTED ACRES; ACQUIRED 2 FEE SIMPLE PROPERTIES TOTALING 1,047.73 ACRES; AND COMPLETED 1 AMENDMENT TO A CONSERVATION EASEMENT, FURTHER RESTRICTING THE EXISTING PROTECTED PROPERTY. ONE OF THE KEY PROJECTS IN FY21 WAS THE ACQUISITION OF MEYER LAKE, AN APPROXIMATELY 995 ACRE PROPERTY LOCATED ALONG THE SAVANNAH RIVER WHICH WILL BE TRANSFERRED TO THE SOUTH CAROLINA DEPARTMENT OF NATURAL RESOURCES TO BECOME A NEW WILDLIFE MANAGEMENT AREA OPEN TO THE PUBLIC.
